ABOUT THIS BID DOCUMENT

This form is used to submit a **sealed bid to purchase an entire section** of tax-delinquent real property offered by the Camden County Collector of Revenue in the **2026 Fourth Sale Offering**. Sections are sold as a single, indivisible group — a bid must cover every available parcel listed below. Partial bids on individual parcels will not be accepted.

Enter your **Total Bid** for the section in the box below the parcel list. Your Total Bid must be **equal to or greater than the Minimum Bid** shown above. Complete the bidder information and sign where indicated. Return the completed form to the Camden County Collector of Revenue by the deadline stated in the published notice of sale. Maps showing the location of the parcels in this section are attached at the end of this document.

BUYER BEWARE. All bids are submitted on a **buyer-beware, as-is, where-is** basis. It is your responsibility to know what you are purchasing and the laws that apply to the tax sale process. Properties may be subject to federal, state or other liens, may contain hazardous conditions, or may be common areas. **There are NO REFUNDS. - Write the following on the **outside of the envelope**:
 - Bidder Name or Company
 - Section Number Bidding On — **this bid is for SECTION #10**
- Do not put multiple bids in the same envelope.** One envelope for each section bid. If you are bidding on three sections you should have three envelopes, each with the section number on it for which it is a bid.
